BACKGROUND

On April 3, 2023, at the regular Board of Commissioners Meeting the Board of Commissioners adopted a resolution authorizing a new Oakland Housing Authority (OHA) Conflict-of-Interest. This new policy was established to provide clear standards for "Designated Employees" who govern, manage, are employed by, or receive income from the OHA, to avoid engaging in conduct that may pose either an actual conflict of interest or the appearance of a conflict of interest.

Designated Employees, according to the policy are defined as:

"A person holding a position who participates in making of decisions that may have a foreseeable material effect on the financial interests of OHA. These positions include but are not limited to employees, commissioners, board members, contractors, and consultants."
